Existing customers can open another Premier Deposit subject to funding the new deposit with at least the minimum Deposit Amount. <b>Can I withdraw money?</b>	Strictly no early withdrawals are allowed, except solely in the event you or a joint account holder dies or are diagnosed with a terminal illness. The Premier Deposit Account does NOT operate on the basis that you can break the deposit and pay a penalty in order to access your funds early.  We will communicate with you one month before the final maturity date of your deposit to advise you of your options. The account holding your Premier Deposit is NOT automatically renewed at the end of the fixed term for a further fixed term.
