<b>What is the interest rate*?</b>	The account operates using Expected Profit Rates. The Expected Profit Rate is currently 0.85% GROSS / 0.85% AER fixed for 6 Months. Profit payments will be paid to your nominated account on an annual basis or upon maturity if the deposit is for less than 1 year.

<b>How do I open and manage my account?</b>	A Transfer Account with BLME must be opened in order to open a Premier Deposit Account. Existing customers can open another Premier Deposit subject to funding the new deposit with at least the minimum Deposit Amount. Existing customers can communicate with us regarding their account via the online web facilities or direct via email to <a href="mailto:savings@blme.com">savings@blme.com</a> <b>Minimum deposit:</b> £1,000.00 <b>Maximum deposit:</b> £1,000,000.00 (or higher at our discretion).
<b>Can I withdraw money?</b>	Strictly no early withdrawals are allowed, except solely in the event you or a joint account holder dies or are diagnosed with a terminal illness. The Premier Deposit Account does NOT operate on the basis that you can break the deposit and pay a penalty in order to access your funds early. We will communicate with you one month before the final maturity date of your deposit to advise you of your options. The account holding your Premier Deposit is NOT automatically renewed at the end of the fixed term for a further fixed term.
<b>Additional information</b>	<b>Tax status:</b> Paid gross of income tax (no tax deducted) <b>'Cooling Off' period:</b> You may cancel your Premier Deposit within fourteen (14) days from the date of our Acceptance. <b>AER</b> stands for Annual Equivalent Rate.
