<b>Can I withdraw money?</b>	Withdrawals are permitted if you provide us with (90 Days) days' notice. There are no penalties for doing this. Once your withdrawal request is accepted by us it cannot be cancelled. <b>Minimum withdrawal amount:</b> £1,000.00
